Temperature: 37°C

Atmosphere: Anaerobic

Propagation Procedure

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #1761 broth from a single test tube (5 to 6 mL) and rehydrate the vial contents.
3. Aseptically transfer this aliquot back into the broth tube. A #1761 slant may be inoculated with 0.1 mL of the cell suspension. Also, streak a blood agar plate to check for aerobic contamination.
4. Incubate tubes and plates under anaerobic conditions at 37°C for 24 to 48 hours. Incubate blood plate aerobically at 37°C.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions. Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be discarded.
